Section A: Guidelines for Accreditation of Air-Carrier for the Provision of Christian Pilgrimage Services

- a. An applicant for accreditation as an air-carrier must be a duly registered Company;
- b. All completed accreditation forms must be scanned to the Executive Secretary through registry@ncpc.gov.ng;
- c. Application fee is Three Thousand, Five Hundred US Dollars (\$3,500) and accreditation fee is Seven Thousand, Five Hundred US Dollars (\$7,500);
- d. Payment by foreign air carriers are to be made to:
 - Account Name: Embassy of Nigeria (NCPC FGN Offshore)
 - Account Number: 39689/57
 - Bank Name: Bank Leumi Le Israel BM
 - Routing Number: 11ILO10800
 - Swift Code: Lumiiitt1v

Payment of the Naira equivalent (in the prevailing CBN approved exchange rate) by Nigerian air carriers are to be made through the remita platform to any Nigerian Bank.

- e. Completed forms should be returned with copies of the following documents:
 - i. Copy of Certificate of Registration;
 - ii. Copy of Memorandum and Articles of Association;
 - iii. Evidence of Share Capital of the Company;
 - iv. Evidence of Directors and Share-holders of the Company;
 - v. Tax Clearance Certificate of the Company;
 - vi. Undertaking to comply with the terms and conditions stipulated by the Commission and the Nigerian Civil Aviation Authority (NCAA);
 - vii. Evidence of payment of application and accreditation fees.

Note:

- i. Accreditation with the NCPC does not constitute a contract binding the Commission to assign pilgrims to you for the provision of air-carrier services, it only qualifies you to offer legitimate air services to Nigerian pilgrims going on Christian Pilgrimage;
- ii. The NCPC reserves the right to review the above requirements or introduce new ones from time to time;
