#### Section A: Requirement for Registration as a Christian Pilgrimage Operator

- 1. An applicant for registration as a Christian Pilgrimage Operators must meet the following conditions:
  - a. the applicant must be duly registered in Nigeria as a Limited Liability Company or an Incorporated Trustee (IT) involved in Christian religious activities (e.g. Churches, Ministries, and Christian service organizations);
  - b. the Company must have a registered Share Capital of not less than Ten Million Naira (\$\frac{10}{10},000,000)\$ and must have the object of pilgrimage operation;
  - c. the Company or IT must be majority owned by Nigerian Christians.
- 2. The applicant must submit the following documents:
  - a. For Companies
    - i. Letter of application addressed to the Executive Secretary;
    - ii. completed Form NCPC 2 (Christian Pilgrimage Operators Form);

- iii. Certified True Copy of Incorporation Certificate;
- iv. Memorandum and Articles of Association of the Company;
- v. Form CAC 1.1 (Application for Registration of Company); or the following CAC Forms: Form CAC 2 (Statement of Share Capital and Return of Allotment, Form CAC 3 (Notice of Situation/Change of Registered Address, Form CAC 7 (Particulars of Persons who are First Directors of the Company;
- vi. Police Character Report of each director of the Company;
- vii. Tax Clearance Certificate for the preceding three (3) years;
- viii. Certificate of Occupancy or Tenancy Agreement or Utility Bill of the applicant's registered address/place of business;
- ix. copy of Memorandum of Understanding with a registered and approved foreign Ground-handler;
- x. Receipt for the payment of non- refundable application form fee of  $\cancel{N}100$ , 000 (through the remita platform);
- xi. Receipt for the payment of licensing fee of  $\maltese 250$ , 000 (through the remita platform).

#### b. For Incorporated Trustees:

- i. Letter of application addressed to the Executive Secretary;
- ii. completed Form NCPC 2 (Christian Pilgrimage Operators Form);
- iii. Incorporation Certificate;
- iv. CAC Form for Registration of Incorporated Trustee;
- v. Constitution;
- vi. Police Character Report on each Trustee of the IT;
- vii. Certificate of Occupancy or Tenancy Agreement or Utility Bill of the applicant's registered address;
- viii. Agreement or Memorandum of Understanding with a registered and approved foreign Ground-handler;
- ix. Receipt for the payment of non- refundable application form fee of >\overline{\text{N}}100, 000 (through the remita platform);
- x. Receipt for the payment of licensing fee of  $\pm 250$ , 000 (through the remita platform).

#### 3. Please note the following:

- a. The Nigerian Christian Pilgrim Commission (NCPC) as a regulatory agency reserves the right to review the above requirements and introduce new ones on the operation of the license;
- b. The license when issued can be withdrawn by the NCPC and the CPO cannot reapply until after a period of two (2) years;
